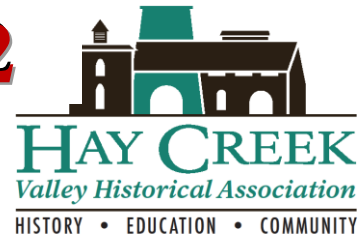

## Christmas Market Rules & Regulations

The Christmas at Joanna Committee invites craft, specialty food vendors, and local non-profits to participate and sell your items in its Christmas Market. Our holiday event will be held Friday – Sunday, December 2-4, 2022 at Historic Joanna Furnace located three miles north of Morgantown, PA on Rte 10.

What we are all about.....

In its 23<sup>rd</sup> year of splendor, the Christmas at Joanna features a wide array of seasonal activities for an entire family. Our event has grown from the idea of a red bow on a door to elaborate Victorian decorations as beautiful as those you might see at any early American event in the United States. This event includes wagon rides, a bonfire, musical entertainment, period re-enactors, Victorian dancing, a live Nativity, toy displays, historic area walking tours, special illuminations, delicious foods, Christmas Market, Christmas raffle, and 1,000 luminaries to guide guests through the historic site.

### WHAT WE EXPECT FROM YOU.....

The following items are to be considered requirements for anyone invited to participate in the event. Your signature on the registration form implies your understanding and compliance with these requirements as set forth by the Christmas at Joanna Committee.

- Items sold must be products approved by the Christmas at Joanna Committee and listed on the application.
- New vendors are required to submit three (3) photos of their product along with their application. Photos can be emailed to [mzerr@haycreek.org](mailto:mzerr@haycreek.org). The registration fee will be required after acceptance into the Christmas Market.
- Vendors will set-up in our outside Christmas Market area located directly behind the Joanna Furnace Mule Stable. Booth size is approximately 10'x10' and includes a roof covering. A table will also be provided. Vendors may bring a kerosene / propane heater to use for warmth. (Note: A heated tent is also located in the Market for a limited number of vendors. Ask for space availability. Vendor's in the tent will receive one 6' or 7' table and ONE metal folding chair to sell items. No extra display racks permitted next to table. **Due to the limited space in the craft tent, vendors are not permitted to have more than one representative at their table to sell items.**)
- Set-up time must be completed within 30 minutes of the event. Stand holders can come on site any time on Thursday or Friday prior to the event to organize their area.
- A registration fee of \$60 will be charged to all Vendors up until September 1, 2022. Thereafter and up until 12/1/2022 vendors will be required to pay \$75 per booth. **Note: returning vendors who do not pay by 9/1 will forfeit their reserved space and their space will be given to a new applicant.**
